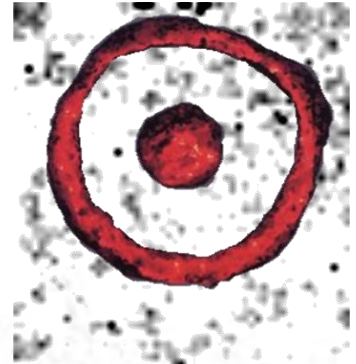

4.1. The community is happy with the proposed landscape design.

4.7. It was felt by the public that due to the new park more people will be attracted to the therefore attracting criminals with access to the park.

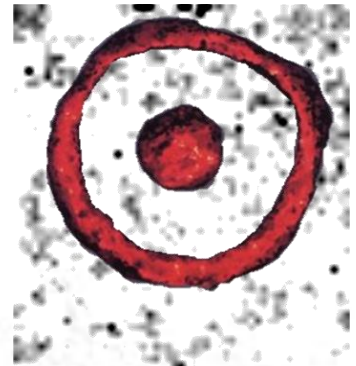
